SUGGESTED SPECIFICATIONS

Model GUF99-FRU1 is a pedestal mounted, vandal resistant and freeze resistant round drinking fountain made from an 18 gage, 304 stainless steel bowl mounted into a reinforced brown concrete aggregate pedestal. Unit shall be activated by a front mounted push button, by using less than 5 pounds of force, which pneumatically activates a water valve mounted below the frost line. An internally mounted adjustable stream regulator shall control the water flow. Bubbler shall be polished stainless steel with a non-squirt feature and operate on water pressure range of 20-105 psig. Unit shall adhere to NSF/ANSI 61, Section 9, Public Law 111-380(NO-LEAD), and CHSC 116875.

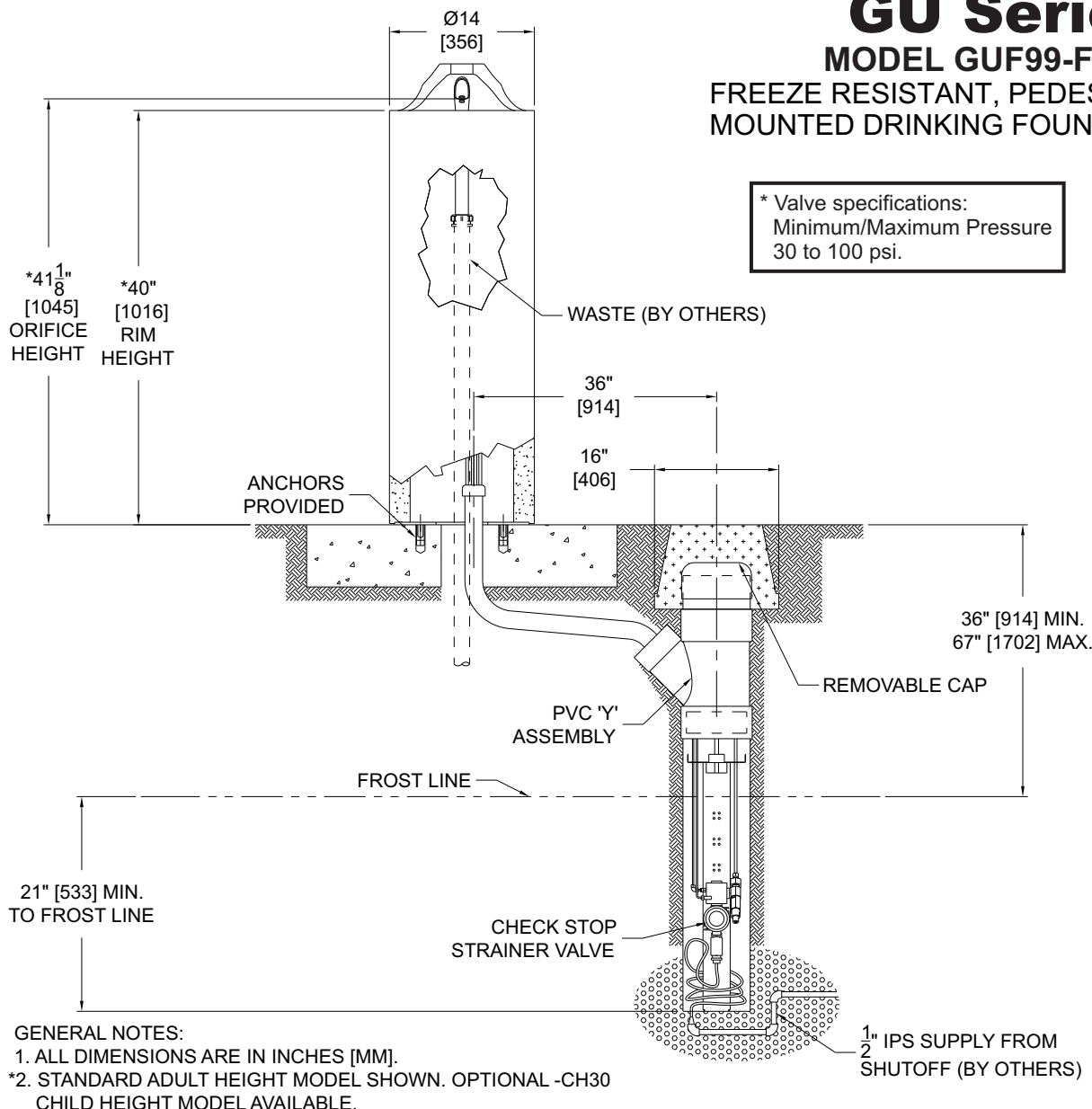
