Bubbler shall be polished stainless steel with a non-squirt feature and operate on a water pressure range of 20-105 psig. Unit shall be activated by a selfclosing, lever operated valve. Unit shall have a 1-1/4" P-trap and a wall bracket. Unit shall adhere to NSF/ANSI 61, Section 9, Public Law 111-380 (No-Lead) and CHSC 116875.


